#### 128. Recreation Ground - Norton Hill

(1) **New Office** – A further specialist report on sustainability was needed to be sent to Building Regulations at B&NES before any further work could be done.

Resolved: to accept the quote for £950.00+VAT obtained by MJW Architects

Plans to go out to tender on the new office were projected on the screen.

- **Resolved:** (1) to query the Air Source Heat Pump with regard to running costs, insulation and its location just outside the fence line. (2) Pending the response to the above query, to accept the plans and go out to tender.
- (2) Fun Day at Norton Hill the meeting with Daniel Moyles is being rearranged.
- (3) Vandalism, Graffiti and litter the spate of vandalism, graffiti and litter at both recreations grounds was noted. Correspondence from the Police outlining how they are addressing this was circulated and had been discussed with the Police at a meeting immediately prior to this Committee meeting.

**Resolved:** To pay for extra litter picks at both recreation sites for April and May at a cost of £300 pcm.

(2) Bridges

Clirs Cooper and Millard had assessed the site and the information on the bridges had been sent to the insurance company. Quotes were received for the replacement of the bridges.

**Resolved:** to accept the fact that the company has £5 million public liability and note that risk is mitigated by two stewards on duty at the bouncy castles whilst it is in operation.

The Committee received the quote for next year's Christmas Lights Display.

**Resolved:** to accept the quote providing it is within budget. To ask Lamps & Tubes to ensure the lights are tested, including the timers, when they are put up.

(3) Fun Fair at Norton Hill

The Committee reviewed the paperwork in relation to the Fun Fair.

Resolved: to stand by the decision to not allow the Fun Fair back on site.

(4) Charity Soap Box Race

A request to run a charity soap box race was received. Whilst the idea of getting involved and running this for the community was welcomed, the Committee stated that it has to be guided by B&NES.

# Notes of a meeting held on Monday 13th March at 6.15pm with the Police

# 1. Pit bikes at the paths between (1) Wesley Avenue and Inner Elm Terrace and (2) Lynton Road and Woodpecker Avenue

Pit bikes are being driven on the above paths causing danger to the rider and others and a noise nuisance to those living adjacent. There was a discussion on options to address the problem. Due to the need to allow mobility scooters, push chairs etc through these walk ways, there does not seem to be a solution which will stop pit bikes. However, it might be possible to deter them and slow them down by installing (1) self-closing gates at both ends of the Wesley Avenue to Inner Elm Terrace path; (2) long chicane barriers at both ends of the Lynton Road to Woodpecker Avenue path.

**Agreed** that the Parish Council would contact B&NES to discuss whether this was feasible and to offer to help find funding.

# 2. Increase in low level vandalism at Norton Hill and Westhill Recreation Grounds

The Police have regular patrols at these sites.

Agreed that the Police write to the local schools asking that this be raised.

# 3. Disruption to those attending the Tuesday evening youth club

Agreed that the Police would step up patrols at this time.

# 4. Illegal parking at Cobblers Way, Longfellow Road, St Peter's Road

Whilst the Police can no longer enforce parking on yellow lines, they do undertake patrols at school drop off and pick up times.

#### Morning Stefan

We have had a meeting with the Police who have raised an ongoing issue of pit bikes using two particular paths in Westfield: (1) the path which runs from Wesley Ave to Inner Elm Terrace and (2) the path which runs from Lynton Road to Woodpecker Avenue.

In discussion, it was felt that the following might be solutions: (1) self-closing gates at both ends of the path between Wesley Avenue and Inner Elm Terrace and (2) long chicane style barriers at both ends between Lynton Road and Woodpecker Avenue.

The Parish Council would be happy to seek funding for this and in the first instance would like to know if such work is feasible please?

Hello Lesley,

I confirm receipt of your email below.

Stefan is on annual leave for a couple of weeks, returning on the 3<sup>rd</sup> April. In the meantime, however, I will forward a copy of this email to our colleagues in the Active Travel Team, as they may be able to offer some advice on the matter. That said, in my experience, there is very little that can be done to prevent motorcycles from using a footpath, without also impacting on access for legitimate users, such as wheelchair users, pushchairs and mobility scooters, for example.

I should also point out that the footpath between Wesley Ave and Inner Elm Terrace is not adopted public highway, so the Council, in its capacity as the Highway Authority, will have no jurisdiction over its use.
